

# TOPPIK Products Ultimate Mother Daughter Beauty Giveaway Sweepstakes

## Official Rules

**NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.**

### 1. Eligibility

The TOPPIK Products Ultimate Mother Daughter Beauty Giveaway (the "Promotion") is open only to legal residents of the fifty (50) United States (including District of Columbia) who are eighteen (18) years or older at the time of entry.
